Sub: Maximum Residue Limits (MRLs) prescribed by Indonesia & requirement of prior notice for export to Indonesia – reg.

The Indonesian Agricultural Quarantine Agency (IAQA) has informed that, as part of IAQA's monitoring program to ensure compliance of Fresh Foods of Plant Origin (FFPO) imported into Indonesia, a few consignments of Dried Chillies from India have been found non – compliant with the Indonesian standards, due to the presence of heavy metals such as Lead and Cadmium, beyond the permissible MRLs.

2. Further, the IAQA has informed that consignments of certain food items (including spices such as Dried Chillies, Celery & Garlic) imported into Indonesia from India shall comply with the following food safety requirements:

a) Every consignment must be accompanied by,

- I) Prior notice issued by Indian exporter (or his/her representative in India) - The exporter may apply online for the prior notice, through the portal, <https://notice.karantina.pertanian.go.id/>
- II) Certificate of Analysis (CoA) issued by the registered laboratories (CoA shall be from an IAQA approved/registered laboratories in India only. The list of approved/registered labs are given in Annexure-I)

b) Prior notice must be issued before the arrival of the consignment at Indonesia.

c) The test results in CoA must not exceed the Maximum Residue Limits (MRLs) prescribed by Indonesia (MRLs are given in Annexure-II).

3. Compliance with the food safety requirements (mentioned vide para 2 above) shall be in addition to the Sampling & Testing requirements under the Quality Evaluation System of Spices Board for export of spices, stipulated vide the Board's Circular No. 17/2021-22 dated 3rd December 2021.

4. In this regard, all exporters of spices and spice products are hereby directed to ensure compliance with the applicable requirements prescribed vide this circular & the Board's Circular No. 17/2021-22 and to exercise due diligence, while exporting spices and spice products to Indonesia.
