Sub: Mandatory Sampling & Testing of export consignments of Spices & Spice products under the Quality Evaluation System of Spices Board-reg

- Ref: 1) Circular No.19/2020 dated 31st December 2020
2) Circular No.14/2020 dated 21st September 2020

Spices Board, vide circular cited at reference 1 had exempted export consignments of Ready to Eat (RTE) products in all forms to all destinations (except EU & UK), from the requirement of mandatory testing. The requirement of mandatory sampling & testing of export consignments of Spices & Spice products has further been reviewed by the Board and the following modifications have been made, with a view to facilitate ease of doing exports.

- In the case of export of Chilli whole, the facility for undertaking export with the Sample Drawn Certificate (SDC) issued by the Board, has been made applicable for South East Asian countries (including Malaysia), Sri Lanka, Bangladesh, Bhutan, Nepal, Pakistan, Afghanistan and China.
- For export of Cumin Seeds to all destinations except USA and Japan, the system for issuance of 'Undertaking endorsed by the Board' has been replaced by the Sample Drawn Certificate (SDC) facility. Accordingly, the designated surveyor of the Board will draw sample from the consignments of Cumin seeds destined to all destinations except USA and Japan and supervise the stuffing of the material into the container and enter the Container number and Customs seal in the SDC. Subsequently, the SDC will be handed over to the exporter, so as to enable export of the consignment without waiting for the cleared analytical report. However, in the case of USA and Japan, the export of Cumin seeds is permitted only with the Cleared Analytical Report from Spices Board.

The updated list of mandatory tests required for export of spices and spice products from the country is attached as Annexure 1, which will be effective from 15th October, 2021. This circular, issued under the provisions of the Spices Board Act 1986 &

* Container stuffing for export of Chilli Whole is permitted based on the 'Sample Drawn Certificate' provided by Spices Board for South East Asian countries (including Malaysia), Sri Lanka, Bangladesh, Bhutan, Nepal, Pakistan, Afghanistan and China.

Container stuffing for export of Cumin Seeds is permitted based on the 'Sample Drawn Certificate' provided by Spices Board to all destinations except USA and Japan. In the case of USA and Japan, exports of Cumin seeds are permitted only with the Cleared Analytical Report OR No Objection Certificate (NOC) from Spices Board.

S Health Certificate (HC) / Official Certificate from Spices Board is required for entry to the EU & UK, for consignment of Chilli and Nutmeg, and for products containing Chilli, and Nutmeg in a quantity of above 20% (either as a single product or as the sum of these products). The Health Certificate will be issued by the Board based on the Cleared Analytical Report for level of Aflatoxin. In the case of RTE products, mandatory tests are required only in cases where HC is applicable (i.e. if the item contains Chilli and / or Nutmeg in a quantity of above 20%, either as a single product or as the sum of these products).

** The Pesticide limits specified for Curry Powders, Curry Masalas and Curry pastes for Japan are applicable only for such products which have a quantity of Chilli & Chilli products of less than 20%. For Curry Powders, Curry Masalas and Curry Pastes which have a Chilli content of 20% and above, the Pesticide limits for Chilli and Chilli products shall apply.

'ex' Where only certain products under any ITC HS Code are to be tested and no specific subdivision under that ITC HS Code exist with description, the ITC HS Code is marked 'ex'.

The Mandatory Sampling & Testing of export consignments of Spices and Spice products does not apply to the consignments that are not intended to be placed on the market viz. trade samples, laboratory samples, display samples for exhibitions, samples that are part of passengers' personal luggage and are intended for personal consumption or use etc., unless their gross weight exceeds 30 kg.
