2. Make/brand name of Projector shall be specified in quotation.
3. The Tenderer shall submit along with the tender an EMD of Rs.2,000/- (Rupees Two Thousand Only) in the form of Demand Draft in favour of Secretary, Spices Board. The EMD should be submitted in a sealed cover marked on the outside with the word 'EMD'. The EMD of unsuccessful Tenderer(s) will be refunded, after short listing of proposals, without any interest. In case the tenderer withdraws from the process, the EMD deposited by him will be forfeited. EMD of the successful tenderer will be retained by the Board as security deposit till the successful completion of System installation. No interest shall be payable on this.
