1. A Compliance statement against each of the 9 points mentioned above should accompany the quotation..
2. The quoted prices for each item should remain constant for the above period.
3. The items should be supplied promptly (Within 2 weeks time), on demand for a period of one year.
4. An **EMD of 2%** of the value in the form of DD in favour of Secretary, Spices Board also need to be enclosed alongwith the quotation.
5. The order will be treated as cancelled, if the supply is not effected during the period specified in the purchase order.
6. The supply should be arranged staggered as per the requirements specified in the purchase order.

7. The items should be supplied at various Regional Laboratories at Kochi ,Mumbai, Chennai ,Guntur, Delhi, Kolkata, Kandla and Tuticorin as specified in the purchase order.
8. If there is a repeated failure in supply of the item during the stipulated period , the name of the party will be blacklisted from the list of suppliers and the order will be issued to the supplier who quoted the next lowest rate.
9. The rates for the consumables with all necessary accessories if any as detailed in the specifications, in Annex A, should give break up of **cost, excise duty/sales tax/VAT, packing and forwarding charges, freight, insurance etc (as applicable)**.
10. If the rates quoted do not include sales tax/excise duty or any other taxes/charges, the same should be specifically stated in the quotation.
11. Quotation should specify the type of sterilization technique used brand name, terms & conditions of supply and the minimum delivery period and minimum order, quantity, if applicable.


