### INVITATION OF BIDS FOR LEASING OF GODOWNS AT SPICES PARK, JODHPUR, RAJASTHAN

Spices Board has established a Spices Park, in Rampura Bhatiyan, Jodhpur, Rajasthan in an area of 60 acres of land for processing and value addition of Seed Spices especially for Cumin. The Board set up common processing, value addition and storage facilities in the Spices Park. The common infrastructure facilities available in the Park includes road, drain, uninterrupted power and water supply etc. The Board allotted land on lease to the prospective entrepreneurs for establishing spice processing unit. Already 10 units are functioning in the park. A few more units is under construction.

Now, Spices Board invites bids for operating the four godowns at Spices Park, Jodhpur as per the following eligibility and terms and conditions.

#### Eligibility

The following are eligible to submit the bid.

a) Spices exporters having valid CRES (Certificate of Registration as Exporter of Spices).

b) Spices Traders having valid GST registration.

c) Farmers Producer Companies having valid registration certificate issued by Ministry of Corporate Affairs.

d) Commodity Exchanges.

e) Central / State Warehousing Corporation.

#### Terms and conditions

- 1. The godown will be leased out "as is where is" condition.
- 2. The details of godown to be leased are given below:

Godown Number. 2 - 7500 sq. ft

Godown Number. 3 - 8600 sq. ft

Godown Number. 4 - 8600 sq. ft

Godown Number. 6 - 8600 sq. ft

3. The godown will be leased out for a period of five years from date of executing the agreement. The lease rent will be increased @ 10% per annum.

- 4. The lease rent along with 18% GST should be paid to the Board every month on or before 5<sup>th</sup> working day of the month.
- 5.The godown shall be used mainly for storing spices and spices products; however other agriculture commodities excluding cereals may be stored along with spices during off season.
- 6.The godown shall not be used for the purpose of storing of cereals and non-agriculture commodities.
- 7. The godowns will be leased to the applicant who has quoted highest rent per sq.feet per month. If the no. of godowns requested by the highest bidder is less than 4, the balance godowns will be considered to the next highest bidders subject to the condition that the next highest bidder agrees to pay the rent at the same rate quoted by the highest bidder.
- 8. In case the highest rate quoted is the same by more than one applicants, preference will be given to the exporters who have established units in the Spices Park, Jodhpur.
- 9.Detailed terms and conditions will be included in the Agreement which will be executed by the highest bidder within 15 days of the receipt of the offer letter from the Board.
- 10. The highest bidder shall pay an interest free Security Deposit equivalent to three months' rent in the form of Demand Draft in the name of Secretary, Spices Board or online bank transfer to Board's Receipt Account. The security deposit without interest would be returned at the time of handing over the facilities to the Board. The security deposit will have to be remitted along with the agreement.
- 11. The highest bidders shall take possession of the godown / godowns within 15 days from the date of agreement and after the receipt of Security Deposit. If the possession is not taken within 15 days from the date of agreement, it will be treated as breach of the tender conditions and the Board has the right to lease the facilities to other eligible firm/agency.
- 12. The godown shall be used only for the purpose intended and shall not use for any other purposes.
- 13. The agreement shall be terminated by both the parties by giving 3 month's notice before the expiry of the lease period.
- 14. The godowns shall not be sub-let to any other firms.
- 15 .Spices Board will provide water and electricity for the use of godown on payment basis.
- 16. Any alterations/ modifications/ additional constructions will not be allowed in the godown.
- 17. The Board will terminate the lease if the facilities are not utilized continuously for more than 3 months or nonpayment of the monthly rent in time.
