Terms and conditions for renting the Built-up area:

- 1. The facility will be rented out in "As is where is" Condition
- 2. The warehouses will be rented out for 5 years from the date of handing over
- 3. The rent will be increased @ 5% per annum.
- 4. Spices Board will provide water and electricity to the facilities on payment on prorate basis.
- 5. The warehouse will be rented out to the party who has quoted highest rent per month as well as meeting other terms and conditions of the Board.

- 6. The highest bidder shall execute an Agreement with the Board within 15 days of the receipt of the offer letter from the Board. (
- 7.
