1. The disposal will be on '**as is where is**' basis.
2. All labour, tools and equipment for loading the items from the Quality Evaluation Laboratory, Kochi, to buyer's trucks shall be at the cost of the buyer.
3. The personnel deputed by the buyer for the disposal action (job) shall strictly obey the safety rules in force.
4. The disposal shall be carried out without damaging the lab premises. In the event of any occurrence of damages, the buyer shall be charged appropriately.
5. The buyers shall have to make full payment for the quantity at the contract rate plus applicable taxes, prior to lifting the items sold to them.
6. Disputes, if any, arisen out of this tender shall have the jurisdiction of the competent court at Ernakulam.

INSTRUCTIONS TO BIDDERS

- 1) Bid is to be submitted within the last date and time specified in the Notice Inviting Tender.
- 2) Bids shall be submitted in the prescribed format, forming part of the tender enquiry.
- 3) The bid shall be written legibly and free from erasing and over-writing. Corrections, if any, should be duly attested by the authorized signatory.
- 4) The bidders are free to inspect the scrap items mentioned in the form before submission of their bid, obtaining prior permission from the officer in charge of the Laboratory.
- 5) EMD Requirements :
 - 5.1 Bidders should remit the EMD as indicated in the Notice Inviting Tender by way of RTGS / NEFT to Spices Board's Bank Account No.7176002100002354 with the Punjab National Bank, Vennala Branch, Kochi (IFSC : PUNB0717600).
 - 5.2 The documentary evidence for having made the RTGS / NEFT payment shall be submitted along with the bid documents.
 - 5.3 Bid without EMD will be rejected unless specifically exempted by the Government from payment of EMD for which reasons and **proof have to be enclosed along with the Bid.**
 - 5.4 EMD shall be valid for three months.
 - 5.5 EMD of the unsuccessful bidders will be refunded (without any interest) within 45 days from the date of opening of tender.
 - 5.6 EMD amount of the successful bidder will be adjusted against the Security Deposit of 25% of the quoted amount (without GST amount).
 - 5.7 EMD will be forfeited if the vendor withdraws or amends its tender or derogates from the tender in any respect within the period of validity of its tender.
- 6.1 **If the bid being submitted by a Partnership firm**, it must be signed by a person holding a Power of Attorney authorizing him to do so. **Such Power of Attorney shall be enclosed with the bid and it must disclose that the firm is duly registered under the Indian Partnership Act.**
- 6.2 **If the bid is made by a Limited Company**, it shall be signed by a duly authorized person and **evidence of such authorization shall be enclosed with the bid.**
- 6.3 Bids submitted without fulfilling the above and in contravention to the Tender Notice are liable to be rejected.

6.4 The Tender Notice and its Annexures (Annexures-A to C under Section-I, Sections II to V & the Bid Form) shall form part of the contract.

6.5 The contract shall be governed by the Indian Contract Act, 1872 and subsequent revisions / amendments. All payments due from the bidder under the contract shall be made in Indian currency.

2. **SECURITY DEPOSIT** :The successful bidder shall remit Security Deposit equivalent to 25% of the Sale Order value (without GST @ 18%) to Spices Board's Account No.7176002100002354 with the Punjab National Bank, Vennala Branch, Kochi (IFSC PUNB0717600) within 15 days of Spices Board's despatch of the Sale Order, and proof for the remittance shall immediately be submitted at the Quality Evaluation Laboratory of the Spices Board at Palarivattom, Kochi 682 025.
 - 2.1 The above Security Deposit will be adjusted against the Sale Order value with GST @18% to be remitted to the Spices Board.
3. The items covered in the Sale Order can be lifted by the successful bidder after effecting remittance of the order value with 18% GST, duly adjusting the Security Deposit amount if remitted, to Spices Board's Account No.7176002100002354 with the Punjab National Bank, Vennala Branch, Kochi (IFSCPUNB0717600) and on production of the proof for the said remittance at the Quality Evaluation Laboratory of the Spices Board at Palarivattom, Kochi 682 025.

8. Safety Rules applicable to Contractor's workmen should be strictly followed while working in Board s laboratory premises.
