I. Introduction:

Spices Board (Ministry of Commerce and Industry, Government of India) is the organization for the development and worldwide promotion of Indian spices and spice products. The Board is also responsible for the Production, Research, Development, Domestic Marketing & Export Promotion of Cardamom. Small Cardamom, widely known as the Queen of Spices is native to Western Ghats, with the production centered in the states of Kerala, Karnataka and Tamil Nadu in a total area of around 70000 ha. The total production of small cardamom in India was estimated around 20,000 tons per annum and Idukki district in Kerala alone accounts 90% of the production of small cardamom in India. Most of the small cardamom farmers are small and marginal in nature (about 40500 holdings) and they depend on cardamom cultivation for their livelihood. The Board implements various programmes, schemes, trainings etc for increasing production and improving the quality of cardamom. The multifarious programmes of the Board for the cardamom sector are implemented by the Board's office network, Departmental Nurseries & Farms, spread across the small cardamom production belt

India has a strong domestic demand (around 80% of the production is consumed domestically) for small cardamom. Besides, Indian small cardamom, owing to its rich intrinsic qualities, has found applications intertwined with the cultural traditions of the people of Middle East. Saudi Arabia with a consistent share of over 50% in export quantity and value, is the leading export destination for Indian Small Cardamom.

The Cardamom (Licensing & Marketing) Rules 1987 (as amended till 2018), framed in accordance with Section 38 of the Spices Board Act 1986 and enforced by the Spices Board, govern the primary sale of small cardamom in India. As per the Rules, a cardamom grower shall sell his produce through a licensed auctioneer or to a licensed dealer. Hence and to provide better marketing facilities for cardamom growers, the Board has established two e-auction centers at Puttady in Idukki District of Kerala and Bodinaykannur in Theni District of Tamil Nadu. The e-auctions are conducted alternatively at Puttady and Bodi Centre from Monday to Saturday, with two auctions per day. Manual auction licenses are also issued in the states where e-auctions are not conducted.

As per the Cardamom (Licensing & Marketing) Rules 1987 Rules, Spices Board issues licenses to the Auctioneers to conduct manual / e-auctions and Dealer Licenses to cardamom Traders (to buy cardamom from farmers or through

auctions). At present, the licenses have been issued to 12 Auctioneers to conduct e-auction for the block period of 2020-23. In addition, the Board has issued/processed about 500 dealer licenses to cardamom traders across the country during 2020-23 block period. The licenses are issued for a block period of three years.

III. Information to Participating firms/Agency:

- 1. The bid documents should contain the full scope, action plan, time required for completion and deliverables
- 2. The time frame for development of the software will be maximum 30 days from the date of award of work
- 3. Spices Board is not bound to accept any of the proposals submitted.
- 4. At any time before the submission of bids, Spices Board may, for any reason, whether at its own initiative or in response to a clarification requested by an invited firm, amend the tender document. Such amendment shall be informed to the bidders by publishing in website and shall be binding on them. Spices Board may at its discretion extend the deadline for the submission of bids.
- 5. During the period of availing the service from the bidder (as Software as a Service) by Spices Board, all bug fixes and minor change requests, shall be fulfilled by the selected bidder.
- 6. The selected bidder shall provide a minimum notice period of 6 months in the event of withdrawal of services to the Board.
- 7. Payment to the bidder shall be made by Spices Board at **the end** of each quarter or the payment will be made in advance in quarterly basis subject to submission of Bank Guarantee issued by nationalized / scheduled bank equivalent to quarterly amount.
- 8. The service shall be provided for a minimum period of 5 years for which the performance guarantee in the form of Bank Guarantee (BG) issued by nationalized / scheduled bank shall be submitted by the vendor before the commencement of service. The BG amount shall be equivalent to 3% of total contract value for 5 years and shall be valid for 5 years 3 months.
- 9. The service may be extendable for further period of 5 years, if Board desires

10. The applicant is required to visit the Spices Board website for any changes or amendments in the tender before submitting their tenders.

IV. Eligibility Criteria

Supporting documents proving the eligibility criteria shall be uploaded while submitting e-tender.

Tender shall be submitted by those companies/firms/organizations who meet the following eligibility criteria.

- The bidder shall be registered entity in India, with the necessary Income Tax & GST registrations. [Copy of PAN & GST Certificate to be uploaded by vendor]
- 2. The bidder shall be in existence for the **past 05 years** and shall have at least a minimum business turnover of **Rs.10.00 lakh** per year [Proof to be uploaded by vendor: Latest Balance Sheet]
- 3. The bidder shall have proven track record in developing and successful implementation of web based software applications **during the last 5 years.** [Proof to be uploaded by vendor (i) Work Order (ii) Project completion certificate / letter from the client as a proof of successful implementation]
- 4. The bidding company should have employee strength of at **least 5 employees.** [proof to be uploaded by vendor viz., latest salary slip]
- 5. Bid Security Declaration [Proof to be uploaded : Bid Security Declaration in the format given under Annexure 3]

V. Pre-Bid Meeting

Scope of Work

Present E-auction system for Cardamom

To ensure remunerative prices to the farmers, a manual auction system was established for sale of cardamom from 1980 onwards. Further, the Board has introduced electronic auction of cardamom for the benefit of growers and opened full-fledged e-auction centers at Bodinaykanur in Tamil Nadu and at Puttady in Kerala during 2007. The main objective of the e-auction is to make the auction process more transparent, to ensure accountability in the system and to help the growers in realizing better prices. Currently more than 90% of the production is sold through the e-auction system.

The current e-auction system is intranet-based process and standalone servers and bidder terminals are arranged in both the centers to conduct the e-auction. The Stake Holders of the Systems are as follows:

- ➤ Grower: Who intends to sell the cardamom
- Auctioneer: Who are licensed by the Board. They are bound to establish required pooling centers in the growing regions to facilitate the collection of cardamom from the growers for sale through e-auction
- ➤ Dealer: Who are licensed by the Board. They are the buyers to purchase cardamom from auction

Sequence of activities in e-auction process

The licensed Auctioneers has to establish pooling centers across the district to enable the growers to pool their cardamom for sale. While pooling the produce by the growers, the Auctioneers will take sample of 1500gm from each lot of cardamom pooled by the farmer at pooling centre. After pooling the Cardamom by the growers, the auctioneer has to issue a crop receipt to the growers. The Auctioneers will transport the pooled cardamom to their Central Storage godown before the auction day. On the day of auction, the auctioneers bring the samples of the lots to the E-auction Centre. During auction, the cardamom samples are distributed to the Traders participating in the bidding each lot.

E-Auction Process

The key performance activities in the present e-auction system are given below

- ➤ The e-Auction will be scheduled by the Spices Board. The date, time and center for each auctioneer will be fixed and published by the Board
- ➤ The Auctioneers are allowed to commence the collection of material for auction from the growers through their approved pooling centers two days prior to their auction scheduled by the Board
- ➤ The farmers will come to the pooling centers of the respective auctioneers for handing over their produce to the auctioneers and the auctioneer has to accept the material
- > The Cardamom brought by the grower has to be pooled and packed in to bags of 50 Kgs each and has to give a lot number to the concerned farmer
- ➤ While pooling the Cardamom, the Auctioneer has to give a crop receipt to the concerned grower by specifying the lot No, weight of the lot, no. of bags and date of auction
- ➤ The Auctioneer is also allowed to take 1500 kg of Cardamom from each lot pooled by the grower as sample to be distributed in the auction center on the day of Auction
- After the pooling of Cardamom, the entire lot and respective samples will be moved to the main warehouse of the Auctioneer
- ➤ The entire produce pooled by all the farmers will be kept in their main warehouse and sample of 1500gm taken from each lot will be moved to the auction center at the day of Auction
- ➤ In the day of auction, the auctioneer will hand over the details of the lots of Cardamom pooled by each auctioneer to the administrator of the auction center who will be an employee of the Board in CSV format.
- > The administrator will load the details of the lot to the Server which include the name of the grower, Type of Grower, lot No, weight of the Lot, number of Bags, moisture content, liter weight of the produce, GST No if available, reserve price if any specified by the grower etc. By this procedure, the first part of the e-Auction is completed

In the Second Stage

- After loading all the details of the lot for auction for the particular date, the administrator of the auction center will give permission to commence the e-Auction
- ➤ The Auction Master, who is a representative of the Auctioneer will commence the Auction by fixing the initial price of the lot
- > The Licensed dealers are provided with a user id and password. The

- dealers have to log into the system (Bidding Terminal) provided in the eauction centers, to participate in the Auction.
- During the auction process, the identification of bidders is protected
- ➤ Then the auctioneer will distribute the sample of 1500gm taken from each lot to each of the bidders and after assessing the quality of the produce the bidder will start the bidding
- ➤ Auction Master will permit to commence the Auction by fixing the starting price
- ➤ Then the bidders can star the bidding by entering the enter key
- ➤ While entering the enter key once, the price will be added by Rs.2/-. In the software provision is also given to enter a bid value increment up to Rs.9/-
- ➤ If nobody is responding to the last enter key for a period of 7 seconds (configurable), the last price entered will be taken as the final bid value of the lot.
- ➤ Then the system will check whether the farmer has placed any reserve price for this particular lot
- ➤ If the maximum price bidded by the dealer is less that the reserve price specified by the farmer, the lot will be treated as withdrawn, otherwise it will be assigned to the concerned dealer
- > A main electronic display board is kept in the auction hall to show lot no, quantity, number of bags, Average price, whether the lot is pooled by a farmer or a Trader, current highest bid etc. of each lot. Provision is also given to display the bidding process in the public domain

Purpose

The present e-auction system is conducting in the e-auction halls established at Puttady, Idukki District of Kerala and Bodinayakanur of Theni District of Tamil Nadu. The system is working in Local Area Network (LAN) and fully restricted from the public domain. Hence, dedicated servers with LAN Nodes are established in both the centers and the system is managed by the System Engineers posted in both the centers. Hence, the physical presence of all the buyers is necessitated in the auction hall to participate in the auction. In this regard, it may please be noted that most of licensed dealers who are the buyer of Cardamom in the auction are from Madurai, Theni & Cumbum districts of Tamil Nadu and Idukki district of Kerala. The norms for interstate and

intrastate movement, social distancing etc., is now restricted due to COVID 19 pandemic. This warrants to inter connect both the centers to conduct the e-auction so that the buyers from Madurai, Theni and Cumbum district can assemble in Bodinayakanur e-auction center and that from Kerala can be assembled at Puttady e-auction so that the same e-auction can be conducted in both the centers. Such a transformation of the existing e-auction process will help to participate a greater number of participants for the same auction without interstate/district travel. Hence, the Board would like to link both the centers to for conducting simultaneous auction at both centers.

Objective

The Board would like to invite Proposals from reputed and experienced vendors who can provide software solution as 'Software as a Service' model, for conducting the e-auction simultaneously in two or more centers. The major objective are as follows:

- 1. To develop new software as per the existing procedure of e-auction, but to conduct the auction simultaneously in two or more centers
- 2. The functional activity will be same but the scope of the development includes additional provisions and procedure to conduct the auction simultaneously in two or more centers
- 3. Dissemination of auction details in the public domain is to be restructured
- 4. The development includes manage and maintenance of the software
- 5. Software should support 130 users (nodes) concurrently and should be scalable based on further requests from Spices Board.
- 6. Software should be web based and accessible from leading web browsers (latest versions), and support Windows and Ubuntu Operating Systems.
- 7. Software shall be hosted in a cloud (cloud location must be India) and the software shall be provided to Spices Board as 'Software as a Service' (SaaS) model.
- 8. Access to software shall be restricted based on the public IP addresses provided by Spices Board.
- 9. Bandwidth requirement at the auction centres shall be specified by the vendor. Ensuring bandwidth at the auction centres will be the responsibility of Spices Board.
- 10. The software shall be available with an uptime of 99%.

It may be noted that, the existing e-auction software is LAN based software and currently used in auction centers of Spices Board. The functional requirements

of the new software to be developed is almost same and are explained above. Hence, proper understanding of the existing system and its procedure and requirement is essential to develop and execute the proposed Software. Hence those who are interested to participate in the bidding process are requested to visit any of the e-auction centers of the Board to witness the existing auction process and to study the functional and technical requirement.
