- 2. The quantity of sheets mentioned are purely indicative and subject to be modified at any time during the process depending upon the requirement in each state and budget allocations during the financial year 2014-15. Tenderers do not have any right to demand on quantity & price.
- 3. Tender notice is called in two bids (Bid A- Technical bid, Bid B-Commercial Bid) system to supply HDPE Tarpaulin / Silpaulin Sheets. Commercial Bids of only those tenderers will be considered who get qualified in the Technical Bid.

- B. The Second Envelope B (as per Annex III) should contain only item wise rates for supply of each item quoted in the format which should be super-scribed as "ENVELOPE B- COMMERCIAL BID FOR SUPPLY OF HDPE TARPAULIN / SILPAULIN SHEETS DURING 2014-15"
- C. Both these envelopes (A & B) should be placed in one sealed envelope super scribed as "TENDER FOR SUPPLY OF HDPE TARPAULIN / SILPAULIN SHEETS" FOR 2014-15 along with the tenderer's name and address. This sealed tender should be sent to Director [Dev], Spices Board, Palarivattom Post, Kochi-682 025, Kerala (as per Annex V).
- 5. The tenderer should quote the prices showing item wise actual rate with break up of basic rate per piece, VAT/ CST/ Taxes, excise duty, octroi etc. and

packaging, loading, freight and unloading charges as given in the commercial bid format. No 'C" form or 'D" form will be issued by the Spices Board. Rates should be given in words & figures.

- 6. Tenderer should quote the rates for the HDPE Tarpaulin / Silpaulin sheets as per technical specification mentioned in the tender.
- 7. Tenderers will remit a Tender fee of **Rs.2,000/- (Rupees two thousand only)** in the form of demand draft from a scheduled / nationalized bank favouring Secretary, Spices Board payable at Ernakulam.
- 8. Tenderers will remit Earnest Money Deposit of Rs......./(Rupees......Only) towards 5 % of the total tender cost in the form of demand draft from a scheduled / nationalized bank favouring Secretary, Spices Board payable at Ernakulam. The Earnest Money Deposit will be forfeited if the tenderer fails to complete the order according to the tender.
- 9. The supplier should enclose lab test reports for the HDPE Tarpaulins sheets supplied to the Board, at the time of delivery, if the production batch is different from the lab test report of the sample given along with the tender application.
- 10. The supplier should declare that HDPE Tarpaulins / Silpaulin Sheets supplied to the buyer under this offer shall be of standard quality and shall be strictly in accordance with the specifications and particulars mentioned in the tender.
- 11. Spices Board shall have the right to draw the samples randomly and get the quality tested to ascertain their conformity to the standards as per specification and BIS standards, if found necessary.
- 12. Spices Board will be entitled to reject the said HDPE Tarpaulins / Silpaulin sheets which may be found not to conform to the above said specification and quality after analysis and the payment for that particular batch will not be paid. If at all paid, the amount will be forfeited by EMD and recovered from the supplier.
- 13. The successful tenderer will have to remit a security Deposit of 10% of the total value of the material ordered for supply on placing confirmed orders. The EMD remitted along with the tender can be adjusted against the Security Deposit referred to above. Alternatively, the successful tenderer can furnish security deposit in the form of Bank Guarantee on any Nationalized / Scheduled Bank for the total amount.
- 14. 25% of the ordered material shall be supplied within 15 days of placing firm order. There after, there shall be regular supply and entire quantity to be supplied within 45 days of placing of order. No extension of delivery period will be allowed.

- 15. On completion of supply at the supply points etc. identified by the Board, payment to the supplying firm will be as follows:
- (a) Subsidy portion allowable to the farmer will be paid to the supplying firm, on completion of supply and receipt of required bills/vouchers along with stock satisfaction certificates from Board's Offices.
- (b) Non-subsidy portion which has to be collected from the farmer will be paid to the supplying firm, after collecting the same from the growers who have received the HDPE/Silpaulin tarpaulin sheets under the Board's programme. The subsidy eligible to farmers are 50% and 33.33% to tribal and general category growers respectively.
- 16. Spices Board shall not incur any liability to pay interest on the bills for delay in payment. Payment will be made after fulfilling the following conditions:
 - a) The analysis report of the random sample taken by the Board's officers in the supply point shows the material supplied is as per specifications contained in the purchase order.
 - b) If shortage or breakage has been reported by the Board's officers, the goods should be replaced at suppliers own cost with sound packing.
 - c) If the material is found to be substandard, underweight, defective, etc., the material will not be accepted and supplier will have to replace the material at his own cost.
 - d) No advance will be paid.
 - e) Spices Board shall not be liable for payment of interest in the event of delay in making payments as specified above due to unavoidable circumstances or circumstances beyond the provision of Spices Board, not withstanding any instructions by other authorities.
- 17. The approved supplier shall not assign or transfer the Board's supply order or any part of it to other agencies.
- 18. No post bid clarification shall be entertained.
- 19. Spices Board reserve all the right to increase or decrease or change the quantity of HDPE Tarpaulins / Silpaulin Sheets while placing order.
- 20. In case of any dispute, the matter will be settled in the jurisdiction of Ernakulam court only.

- 21. Spices Board reserves the right to accept or reject or modify any or all the tenders without assigning any reasons thereof and no representation in this regard will be entertained.
- 22. If, any stage of selection/ supply process, it comes to the knowledge that any supplier is involved if any fraudulent practice or misrepresentation of the facts or tried to influence the selection/ supply process or indulged in any corrupt activities in competing with others, the supply orders placed by the Board can be cancelled and such supplier is liable for blacklisting & further prosecution.
- 23. Tender should accompany 10 sample pieces of one sq. m. of 250 GSM HDPE tarpaulin sheets and 120 GSM Silpaulin sheets. Otherwise, the tenders will be rejected. Supply of sample after the tender process will not be accepted under any circumstances.(Tenderer should ensure that lab test report produced belongs to the sample submitted)
- 24. Any tenderer/ supplier whose product has been blacklisted in the past 3 years will be liable for rejection for that product. Further, in case such information comes to the notice of Spices Board at a later date, the supply order for that product (s) will be liable for rejection and amount to be paid for such product(s) will be forfeited. The supplier should also give declaration in Annex- IV of the tender in this regard.
- 25. Spices Board also reserves the right to select one or more suppliers and award order for supply whole or part of its requirement. Spices Board reserves its right to negotiate or seek clarification before accepting any offer/ tender. While negotiations are carried out, then the purchaser have the right to call only first lowest bidder for negotiation.
- 26. One authorized representative cannot represent two suppliers or quote on their behalf in a particular tender process/ enquiry. If any such quote is noticed, such quote will be rejected.
- 27. The rate quoted shall be inclusive of all taxes, and packing, freight, loading and unloading charges and valid upto 31st March 2015.
