# Request for submission of Proposal for consultancy work to Develope and Implement an Integrated OMS &EMS System

#### **Objective:-**

The Quality Evaluation Laboratory (QEL) of Spices Board (under Ministry of Commerce&Industry,Govt.of India)at Kochi proposes to develope and implement an Integrated Quality and Environmental Management System,as per the ISO 9001:2015 & ISO 14001:2015 Version from the current version(transition work) to a software based management system.

# **Background of the activity proposed:-**

The QEL is now certified under ISO 9001: 2008 version and under ISO 14001:2004 version by BSI,India for testing and certifying the spices &spice products for the Quality and Safety aspects,as per existing national/international specifications. The laboratory is also accredited by ISO/IEC 17025:2005 for its competency in testing for chemical and biological field under NABL. The laboratory got its ISO 9001 in the year 1997 and ISO 14001 in 1999 and has a matured system with well documented procedure which runs under the software QUADMAS for ISO 9001 and under Hard copy for ISO 14001. Since the laboratory proposes to upgrade the current two version to 2015, and to integrate and work in software mode, the transition work to be commenced in January, 2017 and to complete by the mid of 2017. The laboratory proposes to face the next BSI Assessment under the revised version of 2015 for ISO 9001 &14001 systems in October, 2017.

- (3) Upgrading the Documented information system and applicable Legal requirements
- (4) Prepare the simplified Documented procedure to align and integrate the systems
- (5) Implementation of the same under Software and trail run
- (6) Imparting Training to the personnel working in the laboratory
- (7) Imparting Training to the panel of Interal Auditors of the laboratory
- (8) Conducting at least two Internal Audits(IA) with the above personnel
- (9) Preparing the IA summary and NC Closure as per the system requirements
- (10) Preparing the Laboratory for getting the final Certification as per the requirements.

For timely completion of the activity, a schedule with terms and conditions are invited from the competent person/organization, with their proof of experiences of successfully completing such projects in firms (preferably in Government Food Analytical Laboratories in India).
