निर्यातकों के पास अवधि के दौरान स्पाइसेस बोर्ड के साथ वैध पंजीकरण होना चाहिए और बिना कोई चूक के अपनी **तिमाही निर्यात रिटर्न** बोर्ड को प्रस्तुत की होनी चाहिए। समर्थक दस्तावेजों/प्रमाणपत्रों के साथ सत्यापन के लिए प्रस्तुत किए जाने वाले विवरण का प्रारूप संलग्न है। सभी अपेक्षित दस्तावेजों के साथ विधिवत हस्ताक्षरित और मुहरबंद विवरण सीलबंद लिफाफे (**केवल हार्ड कॉपी**) में भेजा जाना चाहिए, जिसमें **"वर्ष 2017-18/2018-19/2019-20 की अवधि के दौरान महिला उद्यमी श्रेणी के लिए निर्यात पुरस्कार"** लिखा हो और निदेशक (विपणन), स्पाइसेस बोर्ड, सुगंध भवन, एनएच बाई पास, पालारिवट्टम, कोच्ची-682 025 को संबोधित किया जाना चाहिए ।

विवरण प्रत्येक वर्ष के लिए अलग से प्रस्तुत किया जाना चाहिए।

Exporters should have valid registration with the Spices Board during the period and should have submitted their **Quarterly Export Returns** to the Board without fail. The format of details to be submitted for verification along-with supporting documents/certificates is attached. The details along with all the required documents duly signed and sealed should be sent in sealed cover (**hard copy only**) super scribing "**EXPORT AWARD FOR WOMEN ENTREPRENEUR CATEGORY during the period 2017-18/2018-19/2019-20** and addressed to THE DIRECTOR (MKTG), SPICES BOARD, SUGANDHA BHAVAN, NH BYE PASS, PALARIVATTOM, KOCHI 682 025"

The details should be submitted separately for each year.

Last date for submission of details for exporter award is 13th October 2021. Details received after the due date and not in prescribed format would be summarily rejected.
