Candidate shall affix his/her recent passport size photograph in the application form. The candidates reporting after the specified time, will not be allowed to appear in the test

4. In case it is detected at any stage of selection that a candidate does not fulfill the eligibility norms and / or that he/she has furnished any incorrect / false information or has

suppressed any material fact(s), his / her candidature will stand cancelled. If any of these shortcomings is/are detected even after selection, his/her services are liable to be terminated.
