## NOTICE

### **CAPACITY BUILDING PROGRAMME UNDER MARKET ACCESS INITIATIVES (MAI) SCHEME**

Spices Board proposes to conduct training on “Preventive Controls for Human Food : Spice and Spice Products” during 31<sup>st</sup> January to 2<sup>nd</sup> February 2023 at Spices Board, Kochi. This focused training / educational programme is expected to update the knowledge on market access, export expansion requirements. This training programme may help exporters to avoid rejections / rapid alerts / contamination related issues. The programme will be for 3 days and handled by PCQI instructors trained by USFDA.

Applications are invited from the interested spices exporters preferably Manufacturer Exporters having valid CRES issued by Spices Board. Only 20 members will be selected for the training on first cum first serve basis. A maximum of two personnel from each firm will be allowed for this training. However, the Board may accept more than two application from the firm considering the nature and size of the firm.

Application in the prescribed format along with recommendation letter in the Firm's letter head, shall be submitted to the Director Spices Board Kochi through email to [dm.sb-ker@gov.in](mailto:dm.sb-ker@gov.in). There would be a Registration Fee of Rs.2000/- + 18% GST per participant for this training. The registration fee shall be paid in the Board's account through NEFT in advance. The due date for receipt of the **application is 25<sup>th</sup> January, 2023**. The details of the training are as follows :
