विषय : स्पाइसेस बोर्ड की गुणवत्ता मूल्यांकन प्रणाली के अंतर्गत मसालों व मसाला उत्पादों के निर्यात परेषणों का अनिवार्य नमूनन व उनकी जांच -बाबत

संदर्भ : परिपत्र संख्या 14/2020 दिनांक 21 सितंबर, 2020

स्पाइसेस बोर्ड ने, उपरोक्त संदर्भित परिपत्र के अनुसार, शुष्क रूप में तैयार रेडी टु ईट (आरटीई) उत्पादों के निर्यात परेषण, जैसे कि नमकीन, स्नैक, पापड़ आदि को निर्यात-पूर्व अनिवार्य जांच की अपेक्षा से छूट दी थी। बोर्ड, रेडी टु ईट (आरटीई) उत्पादों के निर्यात को अधिक बढ़ावा देने के उद्देश्य से, सभी प्रकार के रेडी टु ईट (आरटीई) उत्पादों की अनिवार्य जांच से एतदद्वारा छूट प्रदान करती है। तथापि, यूरोपीय संघ को निर्यात के मामले में, आरटीई उत्पाद, जिनमें 20% से अधिक मसाला घटक है, उनके लिए स्वास्थ्य प्रमाणपत्र की आवश्यकता होगी, जिसके लिए जांच एक पूर्व-अपेक्षा है।

दक्षिण पूर्व एशियाई देशों, बंगलादेश, नेपाल, मलेशिया तथा चीन को छोड़कर सभी गंतव्यों के लिए मिर्च व मिर्च उत्पादों का निर्यात स्पाइसेस बोर्ड द्वारा लदानपूर्व अनिवार्य जांच के अधीन है। दक्षिण पूर्व एशियाई देशों, बांगलादेश, नेपाल, मलेशिया तथा चीन के मामले में, बोर्ड द्वारा प्रदत्त 'साम्पल ड्रॉन सर्टिफिकेट' के आधार पर निर्यात हेतु कंटेनर स्टफिंग की अनुमति दी जाती है। इसी तरह, संयुक्त राज्य अमरीका तथा जापान को छोड़कर सभी गंतव्यों के लिए, जीरे के निर्यात के मामले में, स्पाइसेस बोर्ड द्वारा पृष्ठांकित घोषणापत्र के आधार पर स्टफिंग की अनुमति दी जाती है।

इसके अतिरिक्त, स्पाइसेस बोर्ड ने, निर्यात करने की सुगमता को बढ़ावा देने के उद्देश्य से, निर्यात हेतु अनिवार्य गुणवत्ता मूल्यांकन के अधीन मसाले व मसाला उत्पादों का आईटीसी एचएस कोड सूचीबद्ध किया है और अद्यतीकृत सूची, जो 4 जनवरी, 2021 से प्रभावी होगी, अनुबंध-1 के रूप में राखी गई है।

स्पाइसेस बोर्ड अधिनियम 1986 और स्पाइसेस बोर्ड (निर्यातकों का पंजीकरण) विनियम 1989 के प्रावधानों के तहत जारी यह परिपत्र, अगले आदेश तक लागू रहेगा।
