**INVITATION OF BIDS FOR LEASING OF WAREHOUSE AT SPICES PARK,

Spices Board has established a Spices Park at Kottagudi Village in Sivaganga District of Tamil Nadu with all basic infrastructure and facilities for processing and value addition of Chillies and Turmeric and warehouses for storage of raw materials and finished products. Now, the Board invites competitive Bids for leasing finished warehouse for Turmeric admeasuring 603 Sq Mtr established at Spices Park, Sivaganga on “as is where is” condition.

Eligibility

The following are eligible to submit the EOI.

- a) Spices exporters having valid CRES (Certificate of Registration as Exporter of Spices).
- b) Spices Traders having valid GST registration.
- c) Farmers Producer Companies having valid registration certificate issued by Ministry of Corporate Affairs.
- d) Commodity Exchanges.
- e) Central / State Warehousing Corporation.

Terms and conditions for renting the warehouse

1. The facility will be rented out in “As is where is” Condition.
2. The warehouses will be rented out for 5 years from the date of handing over of the warehouse.
3. The rent will be increased @ 5% per annum.
4. Spices Board will provide water and electricity to the facilities on payment on prorate basis.
5. The warehouse will be rented out to the bid applicant who has quoted highest rent per month as well as meeting other terms and conditions of the Board.
6. The highest bidder shall execute an Agreement with the Board within 15 days of the receipt of the offer letter from the Board.
7. The highest bidder, after receipt of offer letter, shall pay an interest free Security Deposit equivalent to three months’ rent and a caution deposit of Rs.2,00,000/-

through online bank transfer to Board's Receipt Account.

8. The security deposit and caution deposit without interest would be returned at the time of handing over the facilities to the Board. The security deposit and caution deposit will have to be remitted along with the agreement.
9. The highest bidder shall take possession of the facility within 15 days from the date of signing of agreement and after the remittance of Security Deposit and caution deposit.
10. If the possession is not taken within 15 days from the date of agreement, it will be treated it as breach of the tender conditions and the Board has the right to lease the facilities to other eligible firm/agency.
11. The monthly rent with 18% GST shall be paid to Spices Board on or before 5th of every succeeding month.
12. The facilities shall not be sub-let to any other firms.
13. The Board reserves the right to reject / cancel any or all bids without assigning any reasons thereof.
14. The Board will terminate the lease if the facilities are not utilized continuously for more than 3 months or non payment of the monthly rent in time.

Other terms

1. The bid application shall be submitted in the format given as Annex-1
2. The financial bids shall be submitted in the format given as Annex-2.
3. EMD is not applicable to submit the Bid. However, the bidders shall submit the Bid Security Declaration in the prescribed format as given in Annex-3.
